Quorum

50% of Director Members

Purpose

To monitor, consider and make recommendations to the governing body on standards and other issues relating to the school's curriculum, including all statutory requirements.

The Chair to report summary discussions at FGB and any major issues or decisions to be referred to FGB for ratification.

Terms of Reference

The committee is authorised:

- 1. Ensure that a broad and balanced curriculum is delivered including English, Mathematics and Science, and a broad range of both curricular and extra-curricular activities are accessible to all pupils.
- 2. Ensure that provision is made for the teaching of religious education which includes a daily act of collective worship, the content of which is in accordance with the tenets and practice of the Greek Orthodox faith
- 3. Receive regular reports from the Headteacher on the quality of teaching, the standard of pupil achievement, KPI's, attendance and National Assessments (SATS).
- 4. To ensure children are given opportunities to develop their cultural capital
- 5. Oversee and monitor the school's programme and policies for extended school hours opportunities and day trips, residential visits, off-site activities and enrichment activities
- 6. Ensure that the school's policy for inclusion is fully implemented, in consultation with Headteacher, Deputy, Assistants and inclusion leader
- 7. Monitor progress of curriculum-related aspects of the School development Plan (SIP)
- 8. Identify and receive reports from curriculum link governors
- 9. To review, approve and monitor all curriculum-related policies and their operation, including (but not limited to) those highlighted below
