CONSULTATION FOR PROPOSED ADMISSION ARRANGEMENTS 2026-2027

The Admissions Code of Practice 2021 requires an Admissions Authority to consult each time it proposes to make significant changes to its admissions arrangements.

St Cyprian's Greek Orthodox Primary Academy is the Admission Authority for St Cyprian's Greek Orthodox Primary Academy and administers the admission arrangements on behalf of the London Borough of Croydon for St Cyprian's Greek Orthodox Primary Academy.

The proposal is to reduce the PAN from 2025-2026 to 30 (one form entry).

Accordingly, the Governors of St Cyprian's Greek Orthodox Primary Academy are undertaking this statutory consultation process with the parents and other stakeholders for St Cyprian's Greek Orthodox Primary Academy including:

- parents of children between the ages of two and eighteen;
- other persons in the relevant area who in the opinion of the admission authority have an interest in the proposed admissions;
- all other admission authorities within the relevant area (except that primary schools need not consult secondary schools);
- whichever of the governing body and the local authority who are not the admission authority;
- any adjoining neighbouring local authorities where the admission authority is the local authority; and
- in the case of faith schools, the body or person representing the religion or religious denomination.

St Cyprian's Greek Orthodox Primary Academy wishes to invite interested parties to take part in this consultation on the amendment of St Cyprian's Greek Orthodox Primary Academy Admission Policy for St Cyprian's Greek Orthodox Primary Academy – please see www.stcypriansprimaryacademy.co.uk for the proposed admission arrangements.
